ERO 2020 Budget Economic and Fiscal Update Reporting Requirements

Introduction

1. The Treasury is required to prepare the five year fiscal forecasts for the 2020 Budget Economic and Fiscal Update. As part of its fiscal forecasts this Office is required to furnish a series of schedules to the Treasury so that our financial information may be included in these consolidated fiscal reports.
